

FINAL NOTICE OF ACCEPTANCE
RELATING TO THE INVITATION TO TENDER BONDS
made by the
DELAWARE RIVER JOINT TOLL BRIDGE COMMISSION
with respect to its
BRIDGE SYSTEM REVENUE BONDS, SERIES 2017

Pursuant to the Invitation to Tender Bonds dated May 27, 2026 of the Delaware River Joint Toll Bridge Commission (the “Commission”), as amended by the Commission’s Notice of Amendment, dated June 5, 2026 (collectively, the “Invitation”), the Commission invited offers to tender Target Bonds (the “Tender Offer”) for cash at the applicable Offer Purchase Prices set forth in the Invitation, plus Accrued Interest (if any) on the Target Bonds tendered for purchase to, but not including, the Settlement Date. All terms used herein and not otherwise defined are used as defined in the Invitation.

Pursuant to and subject to the terms of the Tender Offer, set forth below are the principal amounts of the Target Bonds that the Commission is accepting for purchase. All of the principal amounts of the Target Bonds preliminarily accepted for purchase set forth in the Preliminary Notice of Acceptance, dated June 11, 2026, have been accepted for purchase by the Commission.
